#### **FINANCIAL SERVICES COMMISSION ACT, 2001**

#### (No. 12 of 2001)

#### Financial Services (Administrative Penalties) (Amendment) Regulations, 2007

[Gazetted 27<sup>th</sup> September, 2007]

The Executive Council, acting on the advice of the Commission and in exercise of the powers conferred by section 62 of the Financial Services Commission Act, 2001 (No. 12 of 2001) makes the following Regulations:

Citation and **1.** These Regulations may be cited as the Financial Services (Administrative Penalties) (Amendment) Regulations, 2007 and shall come into effect on 31<sup>st</sup> July, 2007.

Regulation 2 amended. 86/2006 **2.** Regulation 2 of the Financial Services (Administrative Penalties) Regulations, 2006 (referred to in these Regulations as the "principal Regulations") is amended

- (a) by deleting subregulation (1) and substituting the following:
  - "(1) In these Regulations,

"the Act" means the Financial Services Commission Act, 2001;

"late payment penalty" means an administrative penalty imposed by the Commission under regulation 5A.";

- (b) in subregulation (2),
  - (i) by deleting the words "the Schedule" and substituting "the Schedules"; and
  - (ii) by deleting the words "any regulatory legislation" and substituting "unless the context otherwise requires, any financial services legislation";
- (c) in subregulation (3), by deleting the words "any regulatory legislation, the Regulatory Code or any directive issued by the Commission" and substituting "any financial services legislation or the Regulatory Code";

- (d) in subregulation (4), by deleting the words "the Schedule" and substituting "Schedule 1"; and
- (e) by inserting after subregulation (4), the following subregulation:

" (5) In determining whether a late payment penalty is payable by a licensee, a fee, charge or penalty is deemed not to have been paid until it is paid in full.".

**3.** Regulation 3 of the principal Regulations is amended

Regulation 3 amended.

(a) by deleting subregulation (1) and substituting the following subregulations:

" (1) This regulation and regulations 4 and 5 apply to any contravention, other than a contravention for which a late payment penalty is payable.

(1A) If the Commission considers that a licensee has committed a contravention to which this regulation applies, it may impose an administrative penalty on the licensee, with respect to the contravention, as provided for in this regulation and regulations 4 and 5.";

- (b) in subregulation (2)
  - (i) by deleting the word "subregulation (1)" and substituting "subregulation (1A)"; and
  - (ii) by deleting the words "the Schedule" and substituting "Schedule 1"; and
- (c) by repealing subregulations (3) and (4).

### **4.** Regulation 4 of the principal Regulations is amended

Regulation 4 amended.

- (a) by inserting after the words "penalty on a licensee", the words "for a contravention in respect of which this regulation applies"; and
- (b) by repealing subregulation (7).

**5.** Regulation 5 of the principal Regulations is amended by inserting after the Regulation 5 words "on a licensee", the words "under regulation 4".

**6.** The principal Regulations are amended by inserting after regulation 5, the Regulation 5A following regulation:

- (a) any fee or charge payable under the Act or any regulatory legislation; or
- (b) any penalty payable under these Regulations

on or before the date upon which the fee, charge or penalty is due for payment.

(2) Where the Commission decides to impose a late payment penalty on a licensee under subregulation (1), it shall send a penalty notice to the licensee stating

- (a) the fee, charge or penalty in respect of which the penalty is imposed; and
- (b) the amount of the proposed penalty calculated in accordance with Schedule 2.

(3) Subject to regulation 8(6), a licensee that receives a penalty notice shall pay the penalty stated in the notice to the Commission within fourteen days of receipt of the notice.".

- **7.** Regulation 7 of the principal Regulations is amended
  - (a) in subregulation (1), by inserting after the words "to a licensee", the words "under regulation 3(1A)"
  - (b) by inserting after the words "penalty on a licensee", the words "for a contravention in respect of which this regulation applies"; and
  - (c) by inserting after subregulation (2), the following subregulation:

" (3) The Commission may not issue a penalty notice under regulation 5A more than six years after the date upon which the fee, charge or penalty became due for payment.".

#### 8. Regulation 8 of the principal Regulations is amended

- (a) in subregulation (3), by deleting the words "the Schedule" and substituting "Schedule 1";
- (b) by inserting after subregulation (2), the following subregulations:

" (3) Where a licensee has, by reason of committing more than one contravention, become liable to more than one penalty, the Commission may compound the penalties.

Regulation 7 amended.

Regulation 8 amended.

(4) The Commission may agree to the payment of an administrative penalty in instalments over such period of time as it considers appropriate.".

**9.** The Schedule is amended

Schedule amended.

- (a) by redesignating the Schedule as "Schedule 1"; and
- (b) in the table of administrative penalties, by deleting in the first column the provisions with respect to category 7 (late payment of fee or penalty) and the associated penalty in the second column, and substituting the following:
