- Citation. 1. These Regulations may be cited as the Financial Services Commission (Financing and Money Services Fees) Regulations, 2010.
- Fees. Schedule 2. The fees specified in the Schedule shall apply in relation to the Financing and Money Services Act.
- Commencement. 3. These Regulations come into force on the 31<sup>st</sup> day of March, 2010.
