

## Update to the UK Sanctions List: UN Iraq, Cyber and Migration Sanctions regime

Please be advised that on 12 August 2025 the UK Government has made administrative amendments to the designation of 1 Individual under the Global Irregular Migration Regime, 2 individuals under the Cyber regime. 2 duplicate listings under the Cyber Sanction's regime have been removed.

Furthermore, 1 administrative amendment has been made under the UN Iraq sanctions regime. This reflects the recent update made by the UN Security Council Iraq (Resolution 1518) Sanctions Committee.

Please be advised that an update has been issued to the UK Sanctions List. The Consolidated list of Financial Sanctions has also been updated. This notification is provided to ensure that all relevant persons under the jurisdiction of the Virgin Islands are informed promptly of these changes
