



Update to the UK Sanctions List: Russia Regime

Please be advised that an update has been issued to the UK Sanctions List. The Consolidated list of Financial Sanctions has also been updated. This notification is provided to ensure that all relevant persons under the jurisdiction of the Virgin Islands are informed promptly of these changes.

Details of the Update:

- On Friday, 12 September 2025 the UK Government has designated the following 27 entities, 3 individuals and specified the following 70 ships under the Russia Sanctions Regime (the Russia (Sanctions) (EU Exit) Regulations 2019 (as amended)) and are subject to sanctions:
