



Update to the UK Sanctions List: Russia Sanctions Regimes

Please be advised that an update has been issued to the UK Sanctions List. The Consolidated list of Financial Sanctions has also been updated. This notification is provided to ensure that all relevant persons under the jurisdiction of the Virgin Islands are informed promptly of these changes.

Details of the Update:

On Wednesday, 15 October 2025 the UK Government designated the following 34 entities and 5 individuals and specified the following 51 ships under the Russia (Sanctions) (EU Exit) Regulations 2019.
