



# Update to the UK Sanctions List: Cyber Sanctions Regime and Russia Sanctions Regime

Please be advised that on 18 July 2025, the UK Government has designated the following 18 individuals and 1 entity under the Cyber Sanctions Regime; the following 3 individuals and 1 entity have been designated under the Russia Sanctions Regime. Furthermore, the following 2 entities have had their designations under the Cyber Sanctions Regime varied.

Please be advised that an update has been issued to the UK Sanctions List. The Consolidated list of Financial Sanctions has also been updated. This notification is provided to ensure that all relevant persons under the jurisdiction of the Virgin Islands are informed promptly of these changes
