



Sanctions Circular No. 124 of 2025

Update to the UK Sanctions List: Russia and Cyber Sanctions Regime

Please be advised that an update has been issued to the UK Sanctions List. The Consolidated list of Financial Sanctions has also been updated. This notification is provided to ensure that all relevant persons under the jurisdiction of the Virgin Islands are informed promptly of these changes.

Details of the Update:

On Wednesday, 19 November, the UK government has designated 1 entity under the Russia Sanctions Regime and designated 2 entities and 4 individuals under the Cyber Sanctions Regime. Furthermore, 1 entity designated under the Cyber Sanctions Regime has been amended.
