



Update to the UK Sanctions List: Counter-Terrorism (Domestic) and Iran (Nuclear) Sanctions Regime

Please be advised that an update has been issued to the UK Sanctions List. The Consolidated list of Financial Sanctions has also been updated. This notification is provided to ensure that all relevant persons under the jurisdiction of the Virgin Islands are informed promptly of these changes.

Details of the Update:

On 3 October 2025 the UK Government has made administrative amendments to 2 entities designated under the Counter Terror (Domestic) Sanctions Regime (the Counter-Terrorism (Sanctions) (EU Exit) Regulations 2019) and 1 entity designated under the Iran (Nuclear) Sanctions Regime (the Iran (Sanctions) (Nuclear) (EU Exit) Regulations 2019).
