Introduction

These Guidelines are issued by the Financial Services Commission pursuant to sections 17 (1) and 41B of the Financial Services Commission Act, 2001 (N0. 12 of 2001) and amend the principal *Guidelines and Operating Procedures of the Licensing and Supervisory Committee* ("the Guidelines") issued by the Commission on 12th March, 2002 and revised in August, 2012. The amendments are in relation to the delegation of authority with respect to financial services legislation and related activities.
