Partnership Act (Amendment of Schedule) Order, 2016

[Gazetted 16th December, 2016]

The Cabinet, acting in accordance with the powers granted by section 89 (2) of the Partnership Act (No. 5 of 1996), makes the following Order:

1 (1) This Order may be cited as the Partnership Act (Amendment of Schedule) Order, 2016.

(2) This Order shall come into force on the 1st day of July, 2017.

2. The Schedule to the Partnership Act, 1996 is amended

(a) in Part I by deleting the figure “\$500” in paragraph (a) and replacing it with the figure “\$850”; and

(b) by replacing Part II with the following:

There shall be paid to the Registrar fees as follows:

(c) For the issue of a certificate of limited partnership of good standing, other than at the time of the registration of a limited partnership	\$50
(d) For the issue of a certified copy of a certificate of limited partnership of a limited partnership	\$100
(e) For the issue of a copy or extract of any other document or part of a document	\$50
(f) For the reservation of	
(i) a name	\$50
(ii) the same name for successive 90 day periods	\$150
(g) For the inspection of each entry in the Register of Limited Partnerships	\$10
(h) To conduct search or inspection of a file or other document kept by the Registrar	\$30
(i) For the registration of Articles of dissolution and issuing of certificate of dissolution	\$300
(j) For any other service provided by the Registrar for which a fee is not prescribed	\$100”.
