Public Statement No. 12 of 2026

GREAT EASTERN ADVISORY (GEA) CORP

Tortola, British Virgin Islands – 27th May 2026 The British Virgin Islands Financial Services Commission (the **FSC**) considers it necessary to issue this Public Statement in order to protect the public interest and the interests of any customers or creditors of **GREAT EASTERN ADVISORY (GEA) CORP (GEA CORP)**, and to make the general public aware that GEA CORP is no longer registered as a BVI Business Company.

The details are:

The FSC has been made aware of the circulation of corporate documents indicating that GEA CORP is an entity incorporated in the Virgin Islands and licensed to engage in brokerdealer services. GEA CORP was incorporated on 12th October 2015 under the BVI Business Companies Act, 2004 (the **Act**). The company was subsequently struck off on 1st May 2018 and effectively dissolved from the Register of Corporate Affairs on 3rd July 2023, following its failure to pay the annual fees required under the Act.

GEA CORP has never been licensed or regulated to carry on any type of financial services business in or from within the BVI.

GEA CORP is no longer registered as a company under the BVI Business Companies Act.

The FSC has issued this Public Statement pursuant to Section 37A (4) of the FSC Act.
