Notes to Mutual Fund SPCs:

- (A) This notification form does **not** apply to **public**, **incubator** or **approved** mutual fund SPCs, who must seek approval prior to creating additional segregated portfolios (see Form SPC-INV1).
- (B) This notification form (SPC-INV2) relates to **private** and **professional** mutual fund SPCs that have created additional segregated portfolios, **only** where the functionaries appointed to the additional segregated portfolios:
 - (i) are the same functionaries appointed with respect to existing segregated portfolios; or
 - (ii) have a principal office in a recognised jurisdiction for the purposes of the Securities and Investment Business Act.
- (C) Where a private or professional fund does **not** meet the criteria detailed in paragraph (B) above, it must seek the Commission's approval **prior** to creating additional segregated portfolios (see Form SPC-INV1).
- (D) For a notification to be considered filed, **all** sections of the SPC-INV2 notification form must be completed and submitted to the Commission by the mutual fund SPC's **authorised representative** (appointed pursuant to section 65 of the Securities and Investment Business Act), along with the following:

Offering Memorandum for each segregated portfolio created
Amendments to the mutual fund SPC's Memorandum and Articles of Association (where segregated portfolios are listed in the constitutional documents)
Current Schedule attached to SPC's Certificate of Recognition
Notification Fees (\$350 per segregated portfolio created)

- (E) The SPC-INV2 notification must be filed within **fourteen (14) days** of the creation of the segregated portfolios. Thereafter, the mutual fund SPC will be subject to penalty fees as prescribed by the Segregated Portfolio Companies (Mutual Funds) Regulations.
- (F) Section 6 of the SPC-INV2 notification form requires the completion and submission of a Segregated Portfolio Sheet (appended to the notification form) for **each** segregated portfolio that the mutual fund SPC has created.
- (F) A mutual fund SPC may submit any other information that it considers helpful to the Commission's assessment of the creation of the segregated portfolio(s).
