Update to the UK Sanctions List: Russia, Belarus, and Global Human Rights Regimes

Today, 19 March, the UK Government has made 1 revocation (de-listing) under the Russia Sanctions Regime and 5 administrative amendments under the Russia, Belarus, and Global Human Rights Sanctions Regimes.

Revocation (de-listing)
