

2024 PIGGY BANK Pageant

COMPETITION RULES

1 ENTRIES

- a. The **MONEY MATTERS BVI** 2024 Piggy Bank Pageant competition is open to students enrolled in kindergarten to Grade 6 throughout the Territory of the Virgin Islands.
- b. Only one First Prize, Second Prize, and Third Prize winner will be announced in EACH of the following four (4) categories:
 - i. **CATEGORY ONE** – Kindergarten (or equivalent grade).
 - ii. **CATEGORY TWO** – Grade 1 and Grade 2 (or equivalent grade).
 - iii. **CATEGORY THREE** – Grade 3 and Grade 4 (or equivalent grade).
 - iv. **CATEGORY FOUR** – Grade 5 and Grade 6 (or equivalent grade).
- c. Limit – One entry per child.

2 THE PIGGY BANK

- a. The piggy bank theme is **Characters and Heroes**.
 - i. Characters may range from those seen on television, in movies, in social media, and in multi-media.
 - ii. Heroes may include superheroes or people in the local or international community whom they admire.
 - iii. Presenting the likeness of the character or hero with the bank may be achieved by modelling with the use of photos or other materials.
- b. Children are required to create their own piggy bank from plastic, cardboard, and/or other child-safe materials. Glass is not acceptable.
 - i. Use of recycled containers is encouraged.
 - ii. **Maximum** Bank size – 16 inches x 16 inches x 16 inches.
 - iii. The Bank **MUST** have a place where money can be inserted and retrieved.
 - iv. The Bank **MUST** be sturdy enough to hold money and to be transported without falling apart.
 - v. Children are given the freedom of creativity to use foam, feathers, straws, pipe cleaners, plastics, shells, paper, rocks, fabric, sand, natural materials and/or any other safe craft materials of choice to decorate and accessorise their Banks.
- c. Adults may provide overall supervisory assistance to the children and must ensure the children are properly supervised if sharp cutters or materials are used, which may cause injury.
- c. The Bank must be the Child's own work.

3 SUBMISSIONS

- a. Banks must be delivered to **MONEY MATTERS BVI** no later than 4:00 p.m. on **Friday 15, March 2024** (the Deadline).
 - i. Drop-offs may be made between 11 – 15 March 2024.

- b. A completed *Piggy Bank Submission Form* **MUST** accompany each entry (*see page 3*).

4 JUDGING

a. The maximum Rubric score is 50. The maximum score can be achieved by gaining points in each of the five grading elements (creativity, functionality, sturdiness, neatness, overall). The Rubric scoring that will be used by the judges is shown below:

STURDINESS	The submission is very likely to maintain form during use and transportation.	The submission is somewhat likely to maintain form during use and transportation. NEATNESS	The submission is neat and clean.	The submission is partially neat and clean.	There are parts of the submission that are messy.	The overall submission is messy.	
OVERALL	The submission has overall excellent visual appeal to children of the creator's age range and shows that the creator took great pride in their work.	The submission has overall good visual appeal to children of the creator's age range and shows that the creator took pride in their work.	The submission has some visual appeal to children of the creator's age range and shows that the creator took some pride in their work.	The submission has little visual appeal to children of the creator's age range and shows that the creator took no pride in their work.	

b. Judges from each participating Bank will review submissions while they are on display to grade based on the above Rubric.

c. Judges will grade each Bank on its own merit (not in comparison to others).

d. Winners will be announced by **MONEY MATTERS BVI** during the 2024 Piggy Bank Exhibition.

5 OTHER

a. **MONEY MATTERS BVI** reserves the right to use any submission and or photos thereof in the future to promote saving and banking among children.

b. Parents/guardians will be called upon to collect the Banks within two weeks after the Piggy Bank Exhibition closes (the collection date).

c. **MONEY MATTERS BVI** reserves the right to retain or dispose of Banks that are not collected by the collection date.
